For best results, apply AgSafe Aquatic-Tabs® in early Spring and during growing season. Easy-to-use, insert two (2) tablets into aquatic soil about 2-3" away from plant crown and about 3-4" deep for every one gallon size plant –or- for every 12-14" of plant spread. Repeat feeding every 60-90 days or when necessary. *Note - Warm pond water climates (75°+) may require more frequent feeding.
