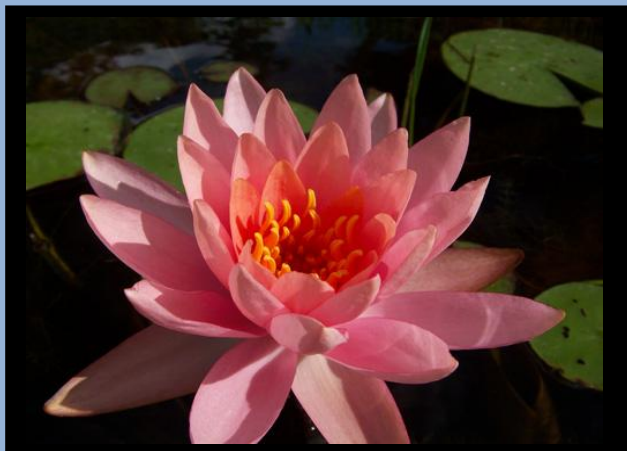

# Generic Aquatic Tablets

## Pond Plant Food

## Monthly Feeding



**Monthly feeding of waterlilies, flowering, and non-flowering pond plants.**

**Suggested Application:**

For best results, apply one (1) pond tablet for every gallon of plant soil during growing season. Easy-to-use, insert one (1) tablet into aquatic soil about 2-3" away from plant crown and about 3-4" deep. Press aquatic soil around the inserted tablet to prevent fertilizer from being released into the water. Feed Lilies and Lotus monthly, and feed Marginals every 6 weeks. Repeat feeding until pond water temperatures begin to drop at the end of the season.

*Note – Some plant species like Lotus, Iris, and other heavy eaters – may require more pond tablets during feeding. As with any fertilizer, it is best to test the product to establish the appropriate number of pond tablets for feeding various types of plant species.*
